Approval: A proposed Plat Amendment to Columbia Bay Estates Subdivision in

unincorporated Lake County.

The Columbia Bay Estates Subdivision, located on the northwest intersection of Grand Avenue (Route 132) and Route 59 in unincorporated Lake Villa has submitted a request to eliminate an existing vacant parcel and redistribute the land to a common space area. Pursuant to Village Code, the Village is required to conduct reviews of amendments to subdivision plats which are located within the Village's primary planning jurisdiction.

The Representative for Columbia Bay Estates, Mr. Larry Fales, is requesting the Village of Lake Villa give approval to file the amendment with Lake County. Under Illinois State Statutes, municipalities may plan for future development or redevelopment within their corporate limits and plan for land use in unincorporated areas within 1.5 miles of their municipal boundary. The County holds ultimate jurisdiction in these areas. At the July 20, 2023 Plan Commission meeting, it was unanimously recommended to approve the proposed Plat Amendment as presented.

CMAP contracted with AECOM and Applied Pavement Technology, Inc. The attached Intergovernmental Agreement signifies that the Village Board accepts the offer of staff assistance services by CMAP and recognizes that these services are provided for the purpose of advancing the implementation of regional plan and other CMAP priorities. Additionally, the agreement notes that the Village's financial contribution for these services is \$3,000.
